- 3. <u>Approval of Minutes</u> The Minutes of the 26th February were agreed, with the following amendment 186A should read 186.

4. Matters arising from 26th February meeting:

Christmas lights –For 2014, the ERA or any other suitable organisation should apply to the council; CG will follow this up if nothing is forthcoming by June.

Baskets and troughs of flowers – Council have ordered them for Eastcote – details to be clarified by CG in due course.

- Blackhorse Public House, disabled access unfortunately there is nothing we can do as works have been approved by planning department.
- Memorial flowers in Elm Avenue IB brought this up at a recent HARA meeting and Tony Ellis
 (Chairman) is to take this up with the Council. We are advised that the Council are in the process of
 formulating a policy document on this matter but there is no time frame. It is likely to be Autumn time
 before any document/decision is available.
- Deane Way and Farthings Close state of roads all that has been forthcoming from the council is that these and other roads are "on the list to be done", but with no timescale.
- Flooding at Old Forge this has been sorted out. We are advised that over the next 12 months all ditches and drains are to be inspected and recorded on a list for future use.
- A.G.M. the £100 donation to the Colne Valley Trust has been agreed.
- Eastcote Post Office We have received the following email from Cllr David Payne "My investigations show that Eastcote PO is on the list of Post Offices considered for closure. This is because it is projected unlikely to be in a break even financial position by March 2015. At this time the exact financial position will be known and a decision made. There will be the opportunity for a shared partner with the P.O. in the present building or in a nearby building with an already existing business. There seems to be no question of Eastcote completely loosing its P.O. I have requested that as more information becomes available, I am kept informed and I will of course keep you informed."

5. New resident issues:

A resident has brought to our attention the disgraceful state of the footpaths and pavements in and around Eastcote and more particularly in the Field End Road shopping area. After general discussion we were advised that everyone report to the Contact Centre all footpaths and pavements in need of repair. IB is to email Jean Palmer on this subject and request that an inspection/repairs of footpaths/pavements take place.

6. Committee Reports

6.1 **Planning** – JR distributed her latest report.

- Initial House redevelopment 150 FER was approved with the proviso that all windows overlooking Moreford Way must be obscure glass.
- 186 Field End Road website shows withdrawn but it is still on the list.
- 2, Mytle Avenue going to appeal.
- 40 Coombe Drive JR to investigate as this appears to be over development.
- 89, Lime Grove LC has written in about this one.

It would appear that the Council is now cracking down on anything that looks like any extension/additional building in the garden that looks like it could be used as a separate dwelling.

6.2 **Police Matters** – IM

- IM attended the last meeting of the disbanding police committee last week; he has been our
 representative for 13 years. It would appear that Resident Associations will have no part to play within
 any new committee but they should have a representative on their ward SNT Panel. CG reported that he
 will be attending Eastcote SNT panel meetings in the future.
- IB reported that the new Board met last week as a training mission. One of the first jobs is to make sure that SNT panels are up and running so that RAs have access to police matters. The model they are working for is a panel for each ward.

6.3 Transport /Road Safety -

- Northwood Hills Town Centre improvements: 24th July-3rd Sep Joel Street southbound closed between Pinner Rd and Tolcarne Drive. Southbound 282 bus diverted to Pinner (Marsh Rd), Bridle Rd and back on route at Field End Rd. H13 bus also implicated
- Track replacement Uxbridge branch: 19th July 10th Aug; during the week the line will be suspended on the Metropolitan line between Uxbridge and Ruislip and on the Piccadilly line between Uxbridge to Rayners Lane. On two weekends the closures will be extended on the Metropolitan line between Uxbridge to Wembley Park and Northwood and on the other two between Uxbridge and Rayners Lane.

6.4 Parks Report

Eastcote House Gardens

- The next community picnic will be on Saturday 7th June from 11am to 4pm.
- There will be a bat walk on Thursday 1st May and a history walk on Sunday 27th July (booking essential for both).
- An archaeological dig will take place between Friday 27th June and Tuesday 15th July.

Eastcote War Memorial

 CG reported on the work that was carried out that morning by Friends of Eastcote House Gardens, Royal British Legion and Council gardening staff, clearing the area behind the War Memorial to allow a greater area for future memorial services.

6.7 Finance

- AH distributed her report, covering the period up to 31st March 2014. The final Accounts for the AGM need to be Audited, CG said that he had a contact and he will contact him asking if he would be prepared to audit our accounts.

- It was pointed out that if we want to use photos of children in the magazine we need their parents' consent.

6.10 Other Reports

HARA – It was reported that the efforts of Northwood RA had helped to stop (currently) the big development in Northwood, near to the Station. It would appear that their efforts have forced TfL to think again and to think more carefully in dealing with local RAs affected by any development they are contemplating.

- 7. <u>AOB</u> We were advised that Cllr David Payne is to be made Freedom of the Borough, the ceremony is on Thursday 3rd April at 6pm in the Civic Centre. The next meeting of the ERA will be his last, and after the elections in May he expressed an interest in being co-opted onto the ERA committee after the elections.

- Gawain Cox will continue with the Website but finds it difficult to attend meetings.
- Deesha Chadha does not want to come on the committee at this stage but will help out when necessary.
- Ian Brooks then explained what his new duties will be within the new Police Committee and that under the circumstances he cannot stand for Chairman, so therefore a new Chairman is required.
